

#### 23 RECOMMENDATIONS ON INTERNATIONAL TREATIES AND BRAZIL'S RELATIONSHIP WITH THE INTERNATIONAL HUMAN RIGHTS COMMUNITY



1 The Observatory is a government mechanism to monitor the effectiveness of the recommendations made to Brazil in order to improve our human rights situation. It is a partnership between the House of Representatives and the United Nations High Commissioner for Human Rights.

Latest significant development: presentation of a report in 2015, positioning itself in rejection to the con- vention. In 2019, there was a request for a public hearing to further discuss the matter.	The topic divides unions and trade union centers and finds bottlenecks in item II of art. 8 of the Federal Constitution, which establi- shes union unity based on territory.
2	Convention on the Non-Applica- bility of Statutory Limitations to War Crimes and Crimes against Humanity	1968 UN General Assembly in the context of impacts from World War II	The treaty entered into force internationally on 11 Novem- ber 1970. Brazil has not yet ratified it and is not even a signatory.	The treaty has 55 State Parties.
3	International Convention on the Protection of Rights of All Migrant Workers and Members of their Families	1990 General Assembly of the United Nations	In 2015, the presidency of the House of Representatives created a Special Committee to analyse the matter, but the legislature ended without its installation. In 2019, the Executive Branch declared that, with the new Migration Law (Law No. 13.445/2017), the full content of the treaty had already been incorporated into the Brazilian legal system. In 2021, after the public hearing with the Observatory to ad- dress the issue, Congressman Carlos Veras, (PT-PE) again requested that a Special Committee be created.	The matters addressed by the Law constitute a scope of protection related to - but do not include the entirety of- the provisions of the international agree- ment. This means that the whole content of the treaty was not included in the Bra- zilian legal system, therefo- re, the need for ratification remains.

4	Adoption of Internal Legislation On the Statute of Rome the international Criminal Court	1998 United Na- tions Organi- zation	Brazil ratified and interna- lized the statute through Decree No. 4.388/2002, but internal legislation was not adapted. The Executive Bran- ch, in 2008, sent to Congress Bill No. 4,038/2008, which has been ready to be voted on in the Plenary of the Hou- se of Representatives since 2012, however no progress in this sense has been made.	The Statute of Rome of the International Criminal Court has 123 State Parties.
5	Kampala amendments to the Statute of Rome	2010 Conference to revise the Statute of Rome (Kampala/ Uganda)	Brazil has ratified it. The Explanatory Memorandum on the subject is "under analysis" by the Ministry of Foreign Affairs.	39 States Parties have ratified the Kampala Amendments.
6	Convention Nº. 189 of the ILO on the Decent Work Conditions for Domestic Workers	2011 Internatio- nal Confe- rence on Internatio- nal Labour Organization (ILO)	It was signed by the Brazilian State and sent to the Natio- nal Congress in 2016. At the end of 2017, the National Congress approved the Con- vention through Legislative Decree No. 172/2017. However, the Executive Branch has not yet enacted and published the decree.	According to the Chief of Staff, there are no obstacles of merit for the approval of the Decree of Enactment. However, according to him, after the end of the mandate of the former president Michel Temer, "the Exhibition of Reasons has been returned to the proposing body", the Ministry of Foreign Affairs said that "since then It has not been resubmitted To the discretion of the President of Brazil".

Consideram-se em pro- gresso as recomendações relativas a esse protocolo, diante da aprovação do tex- to e da não efetivação da promulgação e publicação do Decreto.
8	Protocol Facultative to the Covenant International on Rights Economic Social and Cultural Rights	2013 Assembleia geral das Nações Unidas	According to the Minister of Foreign Affairs, "the signing of the aforementioned interna- tional instrument continues to be discussed internally between the competent bodies and will be subject to a ratification process in due course."	Article 11 of the Optional Protocol also urges States to recognize the competen- ce of the Committee for the investigation of complaints about serious and systema- tic violations of economic, social and cultural rights in the State Parties.

9	Arms Trade Treaty	2013 UN General Assembly	The instrument of ratification of the Brazilian State was deposited at the UN General Secretariat in August 2018. In November of the same year, the agreement came into force for Brazil and internationally.	After ratification, there was progress in national legislation on the subject with the replacement of the National Export Policy for Military Use Material by the National Policy for the Export and Import of Defense Products (regulated in Decree No. 9,607/2018), which contemplates several principles of the treaty.
10	Protocol to Con- vention No. 29 of the International Labour Organi- zation (ILO) on Forced or Com- pulsory Labour	2014 International Labour Con- ference	The protocol has not yet been signed by the Brazilian State.	The Minister of Foreign Affairs informed that the subject is under analysis by the ministries involved (Ric No. 1.570/2020).
