ACORDO ENTRE IFLA E UIA



Agreement

Between The International Federation of Landscape Architects and The International Union of Architects

The President of the International Federation of Landscape Architects (IFLA) and the President of the International Union of Architects (UIA), hereafter referred to as the "Parties" following the spirit of the Memorandum signed in 2006, see mutual benefits between the two organisations, with the aim of maintaining a strong alliance of professional institutions in architecture, landscape, environment, planning, management and design to better serve the professional needs of their respective members, associated partners and thereby society in general. Herewith, the Parties agree to the following:

1. To recognise the distinct nature and standing of the two unique, separate and complimentary professions of architecture and landscape architecture.
2. To collaborate and cooperate in order to strengthen the roles both of architecture and landscape architecture, to reinforce the importance of the spatial context, to enhance the quality of life of human beings, and to provide an enhanced service to support their respective members' professional needs through joint development, commitment and action.
3. The UIA and its member associations shall be responsible for the functioning, regulations and development of the profession of architecture.
4. IFLA and its member associations shall be responsible for the functioning, regulations and development of the profession of landscape architecture.
5. Both parties shall prepare strategic and action plans and make recommendations to their councils, committees, working groups and member associations in furtherance of this agreement.
6. The Presidents and representative members of Executive councils, committees and task forces of both Parties shall be invited to meetings of each organisation as appropriate, to discuss matters of common interest.
7. Both parties shall inform the other of events and activities being undertaken by their organisation and, where appropriate, shall invite official representation at the main events of their organisation.
8. Both parties shall establish links to the other via the web sites of their respective organisation/s.
9. Both parties shall inform their member Associations about the signing of this agreement in order to reinforce the cooperation, collaboration and future development of both professions in their respective countries.
10. This Agreement shall remain effective until one or other of the organisations communicates in writing their desire for either change or termination. (Six months notice should be given in writing of any impending alteration, change or termination of this agreement.)

The IFLA – International Federation of Landscape Architects is a democratic, apolitical and non-governmental, not -for-profit organization and has worked, since its creation in the promotion and recognition of Landscape Architecture as a profession.

Today, the International Labor Organization (ILO) has classified and defined the profession of landscape architecture in its list of professions through the Resolution: ISCO-08 2162 – Title : Landscape Architect.

Most members of this organization have successfully established such profession in the nations to which they belong or have contributed to its expansion, its recognition and appreciation. However, in some countries, like in Brazil, the recognition of Landscape Architecture as a profession and Landscape Architects as the suitable professionals to carry it out lacks of official recognition.

It is precisely to support and encourage the search for such recognition in those countries where this has not happened yet that for the last six decades IFLA has been working on attaining important achievements in conjunction with other international organizations, as the UNESCO. In this sense, IFLA has signed memoranda of understanding with the International Union of Architects (UIA) and the International Society of City and Regional Planners (ISOCARP). Through these agreements the distinctiveness and independence, as well as the authority and reputation of this unique profession that is Landscape Architecture was recognized.

IFLA supports the process of regulation of Landscape Architecture as an autonomous profession in Brazil, as it is expressed by the bylaw 2043/2011. This is an important step to achieve a strong academic and professional base to the future of Landscape Architecture in Brazil, and any measure in contrary does not stands with IFLA history and does not represents IFLA interests.
